#### **BUSINESS UPDATE & FINANCIAL HIGHLIGHTS**

#### Revenue and gross profit

The unaudited revenue and gross profit of the Group for the nine months ended 30 September 2025 were approximately HK\$1,649.2 million and HK\$368.0 million respectively, which were decreased by 2.3% and 12.4% respectively as compared with the corresponding period in previous year.

The overall decrease in revenue of the Group during the nine months ended 30 September 2025 as compared with the corresponding period in 2024 was mainly attributable to the decrease in revenue of the health care and hygienic products business. Such decrease was mainly arising from the disruption when certain production facilities were relocating from China to Cambodia as requested by our customers in response to tariff policies of the United States of America. However, this impact was partly offset by the increase in revenue of the operating supplies and equipment business during the nine months ended 30 September 2025. As a result, the Group recorded a slight decrease in revenue for the nine months ended 30 September 2025 of approximately 2.3%.

The decrease in gross profit margin of the Group of 2.6 percentage points was mainly attributable to the decrease in gross profit margin of the hospitality supplies business during the nine months ended 30 September 2025 as compared with the corresponding period in 2024. Such decrease was mainly due to the increasing manufacturing cost pressure borne by the Group during the nine months ended 30 September 2025.

### Cash and cash equivalents

As at 30 September 2025, the cash and cash equivalents amounted to approximately HK\$425.2 million (as at 30 June 2025: approximately HK\$421.1 million).

#### Trade and bills receivables

As at 30 September 2025, the gross trade and bills receivables amounted to approximately HK\$722.2 million (as at 30 June 2025: approximately HK\$662.4 million).
